### MINUTES OF THE ORGANIZATIONAL MEETING OF THE CITY COUNCIL OF GLENDALE, COLORADO

April 9, 2018

Swearing In/Oath of New Council Positions. Mayor Mike Dunafon administered Oaths to the following incoming Council Members: Dario Katardzic and Doris Rigoni. Council Member Scott Norquist was not present and will be sworn in at the next regularly scheduled council meeting.

1. Call to Order and Roll Call. Mayor Dunafon called the organizational meeting of the Council to order. Veronica Marvin, City Clerk, called roll. The following Council Members were present: Mayor Mike Dunafon and Council Members Scott Brock, Storm Gloor, Dario Katardzic, Lindsey Mintz, and Doris Rigoni. Council Member Scott Norquist was not present. City Manager Jerry Peters, City Attorney Matt Giacomini, and members of City Staff also attended the meeting.

2. Approval of Agenda. Council Member Mintz moved to approve the agenda. This particular motion requires no second. The motion passed unanimously.

3. Appoint the Mayor Pro Tem. Mayor Dunafon re-appointed Doris Rigoni as Mayor Pro Tem.

4. Appoint the Acting Mayor. Mayor Dunafon re-appointed Dario Katardzic as Acting Mayor.

5. Appoint Two Ex-Officio Council Members to the Planning Commission. Council Member Katardzic moved to appoint Mayor Mike Dunafon and Council Member Norquist as the ex-officio Council Members on the Planning Commission. Council Member Mintz seconded the motion, and the vote was unanimous.


